Invitation for Re-Negotiated Procurement –Two (2) Failed Biddings for the project: *Procurement of various Maintenance Supplies*

- 3) The following eligibility and technical documents as well as the Financial Proposal Forms shall be submitted in sealed envelopes, labeled as “Negotiated Document”, with the title of the project, name, address and contact details of the bidder, addressed to the undersigned on or before **August 4, 2023 (Friday) at 9:00AM** at the **BAC Office, 3rd Floor, Procurement & Supply Building, Region 2 Trauma and Medical Center, Brgy. Magsaysay, Bayombong, Nueva Vizcaya:**

1. Valid PhilGEPS Registration Certificate (Platinum Membership) (all pages) following GPPB Resolution No. 15-2021;
2. Statement of the prospective bidder of all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid
3. Statement of the bidder’s Single Largest Completed Contract (SLCC) similar to the contract to be bid, except under conditions provided for in Sections 23.4.1.3 and 23.4.2.4 of the 2016 revised IRR of RA No. 9184, within the relevant period as provided in the Bidding Documents
4. Conformity with the Schedule of Requirements;
5. Conformity with the Technical Specifications;
6. Original of duly signed and accomplished Financial Bid Form;

7. Original of duly signed and accomplished Price Schedule(s).

- 4) Each Bidder shall submit **one (1) original copy** of the above-mentioned documents sealed in one envelope marked as “ORIGINAL DOCUMENTS”, sealing them all in an outer **GREEN** Expanded envelope marked “ORIGINAL BID”.

Submit additional one (1) photocopy of the same documents similarly sealed, sealing them all in an outer **GREEN** Expanded envelope marked “COPY NO. 1

These envelopes containing the ORIGINAL and the PHOTOCOPY shall then be enclosed in one single **GREEN** Expanded envelope.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

- 5) Opening of the eligibility documents, technical documents and financial proposal will be on ***August 4, 2023 (Friday) at 9:05AM via Zoom platform (same link as above).***
- 6) The ***Region II Trauma and Medical Center (R2TMC)*** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
